En este mes dedicado a honrar a las madres, recordemos tomar un momento para







KINGWOOD MAN SENTENCED TO 45 YEARS FOR SHOOTING LONGTIME GIRLFRIEND

A Kingwood man who fatally shot his longtime girlfriend with a shotgun and then tried to portray the murder as a suicide was sentenced to 45 years in prison late Tuesday, Harris County District Attorney Kim Ogg said.

“Domestic violence comes in all shapes and sizes, and we are glad that jurors saw through this defendant’s lies and were able to give the victim and her family justice,” Ogg said.

Matthew Haberland, 38, was convicted of murder for killing 35-year-old Ashley Wallace at their Kingwood-area home on the morning of June 21, 2022. They had been in a relationship for at least five years before the murder.

Haberland shot Wallace on the couch

of the living room while couple’s two young children and the woman’s son were in the home. Haberland then reported to Houston police that he had walked in and found his wife surrounded by blood before rushing the children out of the home.

Police became suspicious after information provided by Haberland did not match the physical evidence and it was discovered that the relationship between Haberland and Wallace was not in a good place. After initially staying on scene while police were investigating, Haberland later left by jumping a fence and making his way to the Kingwood greenbelt trails, where he was apprehended.

On Tuesday, after eight days of trial, a Harris County jury convicted Haberland of murder and sentenced him to 45 years in prison.

Assistant District Attorney Lindsey Bondurant, who is a chief in the DA’s Office’s Domestic Violence Division, and ADA Rashonda Shaw, who is also in the Domestic Violence Division, prosecuted Haberland.

“There was no evidence of suicide — she was not suicidal and did not kill herself,” Bondurant said. “This defendant didn’t take just one life, he ruined so many lives because of what he did. Her family — her children — will have to live the rest of their lives without her.”

Haberland must serve at least half of the prison sentence before he will be eligible for parole.


complices emerged from a parked vehicle and assaulted the victim. The female suspect seized the victim’s phone, keys, and car during the altercation.

SET USAGE BILLS BEGIN FOR SINGLE-FAMILY RESIDENTIAL CUSTOMERS

During the month of May, single-family residential customers will begin receiving set usage water bills as part of Mayor John Whitmire's Water Bill Improvement Plan. Set usage bills will provide customers with consistent water bills while Houston Public Works makes necessary improvements to ensure the accuracy of each customer's monthly water usage readings. Customers will continue to receive set usage bills until they receive an upgraded remote reading device OR confirmation that their current device is working and providing accurate usage readings to the billing system. Last month, Houston Public Works sent letters notifying customers of their set usage. Set usage bills will be printed on blue paper and arrive depending on a customer's billing cycle.

Customers are billed on various dates throughout each month. The City of Houston determined the set usage for single-family residential customers based on the age of their account.

- For customers with accounts older than one year (created before March 1, 2023) the set usage is calculated by using the customer's average water consumption up to 36 months. This calculation does not include usage during the drought (June – December 2023), the winter storm freeze (February and March 2021), potential water leaks on a customer's property and months with estimated billing.
- For customers with accounts less than one year old (created after March 1, 2023) the set usage of 3,000 gallons per month will be assigned based on the average

consumption for new Houston water accounts.

USING MORE OR LESS THAN SET USAGE

- If a customer has a functioning remote reading device and uses less than their set usage, the City of Houston will bill the customer on their lower, actual usage.
- If a customer with a functioning remote reading device uses more than their set usage, they will not be charged for using more water than their set amount.

Single-family residential customers can check to see if their remote reading device is functioning on the Houston Public Works dashboard at improvewaterbills.org.

Customers with questions about their set usage or water bill accounts are encouraged to call 713.371.1400. We also have in-person appointments available Tuesdays, Wednesdays and Thursdays between 10 am – 3 pm at 4200 Leeland (Houston Public Works Water Customer Service Office). There is also a virtual Microsoft Teams option if a customer is unable to attend in person. To schedule an appointment, please visit improvewaterbills.org.

UN MENSAJE DE DÍA DE LAS MADRES PARA NUESTRAS HIJAS

Este día de las madres se cumplen casi ocho años desde que enfrenté la segunda de mis dos dolorosas pérdidas de embarazo. Cada una de ellas me dejó hospitalizada.

Fui bendecida de que las leyes en Texas, y en el país, no eran lo que son ahora. Por eso, pude obtener la atención que necesitaba para estabilizarme.

Ese no sería el caso hoy día.

En la década de 1980, el presidente Reagan firmó la Ley de Tratamiento Médico de Emergencia y Trabajo de Parto (EMTALA, por sus siglas en inglés), garantizando a cada persona el derecho a ser estabilizada en una sala de emergencias, independientemente de su capacidad para pagar. Las nuevas prohibiciones estatales en contra del aborto amenazan con eliminar este derecho y limitar la capacidad de los médicos para administrar tratamientos que salven vidas.

Ya estamos viendo el impacto de estas leyes conflictivas. Reportajes en medios de comunicación han presentado numerosos casos en los que se pusieron en riesgo las vidas de mujeres tras no ser admitidas en hospitales y no recibir estabilización. Recientemente, en el Condado Harris, una mujer tuvo un aborto espontáneo en el baño de la recepción de una sala de emergencia porque se le negó la ayuda médica.

Esta es la realidad actual de mis tres niñas, quienes están creciendo con menos derechos que sus abuelas. Como madre, latina y católica, me indigna profundamente ver cómo va disminuyendo la igualdad al tiempo que le arrebatan las libertades a mis hijas y a todas las mujeres jóvenes. Como abogada y exjueza, me horroriza ser testigo de cómo el sistema legal se convierte en un arma contra las mujeres en lugar de proteger sus derechos fundamentales.

Cuando la Corte Suprema de los Estados Unidos revocó el caso de Roe vs. Wade, borró medio siglo de progreso y le dijo a nuestras hijas que los legisladores de sus estados tendrían la última decisión sobre sus cuerpos.

Cuando la legislatura de Texas aprobó una ley draconiana que prohíbe los abortos sin excepciones en casos de violación o incesto, le dijo a nuestras hijas que sus derechos eran menos importantes que los de un criminal.

Y cuando Texas demandó a la Administración Biden alegando que EMTALA no avala el derecho a un aborto, incluso en casos de emergencias médicas, le dijo a nuestras hijas que la atención de estabilización garantizada para todos los estadounidenses no aplica para ellas.

Por este clima político extremo, la sobrevivencia de nuestras hijas estará condicionada por unas leyes hechas por unos pocos que manejan la Corte Suprema y la legislatura de algunos estados.

En un escenario similar en Idaho, la Corte Suprema decidirá si revoca décadas de práctica bajo EMTALA a favor de la prohibición casi total del aborto, lo que probablemente afectaría el caso relacionado de Texas. Para ambos estados, la muerte debería ser el umbral. Es decir, a un médico sólo se le debe permitir realizar un aborto si determina que la paciente moriría si no se le practica.

Los magistrados de la Corte Suprema, especialmente las mujeres, presentaron ejemplos hipotéticos y reales que incluían evaluaciones como "meramente una enfermedad grave", la pérdida de órganos o la futura capacidad de tener hijos.

La respuesta breve de Idaho sobre la decisión entre la muerte o la opción de "meramente una en-

fermedad grave", es subjetiva; en este estado, la atención médica no debería ser un derecho en absoluto solo hasta que una mujer esté cerca de morir.

Si la Corte Suprema falla a favor de Idaho, las mujeres embarazadas en Idaho, Texas y muchos otros estados no podrán ser estabilizadas en centros de atención. Por el contrario, los médicos se verían obligados a dejar que su salud se deteriora hasta que estén seguros de que podría morir.

Pero, incluso cuando los políticos extremistas trabajan para socavar los derechos fundamentales de los estadounidenses, mi mensaje para nuestras hijas es este: los líderes del Condado Harris lucharemos para proteger su acceso a la salud reproductiva.

Gracias a la asignación directa de fondos federales de la Ley del Plan de Rescate Estadounidense de la Administración Biden-Harris, la Corte de Comisionados que conformamos mis colegas y yo, logró una asignación de seis millones de dólares para nuestro Fondo de Acceso a la Atención Médica Reproductiva.

Dentro de los límites de las leyes de Texas, el Condado Harris está invirtiendo en organizaciones locales para brindar servicios esenciales de atención médica reproductiva, incluido el acceso a servicios integrales de planificación familiar, exámenes de detección de enfermedades de transmisión sexual y más.

En el Condado Harris estamos fortaleciendo la capacidad de las mujeres de controlar su futuro reproductivo, ya sea

a través de la educación, la planificación familiar o las pruebas de salud. Estamos transmitiendo un mensaje alineado con los principios de EMTALA: usted merece acceso a la atención.

Entonces, mientras los extremistas buscan ganar puntos políticos alejados de la mayoría de los estadounidenses, nosotros estamos tomando acciones para apoyar a nuestras madres y familias.

Porque, como el tercer condado más grande del país, ¡el Condado Harris resiste! Y esta madre texana luchará con todas sus fuerzas hasta el final para construir la Texas que nuestras hijas merecen.

GOVERNOR ABBOTT ADDS COUNTIES TO DISASTER DECLARATION FOR SEVERE WEATHER, FLOODING

Weather Service (NWS), areas of North, West, Central, and East Texas face an increased risk of severe thunderstorms bringing excessive rainfall leading to flash flooding. NWS is forecasting extreme river flooding for Central and East Texas river basins. River impacts across major river basins are expected to continue through next week, meaning river flooding threats will persist through that time. Historic releases from lake and reservoir operators will contribute to major flooding for downstream rivers and tributaries. Texans below those reservoirs and along river systems impacted by water releases are encouraged to heed warnings of local emergency management officials. Additionally, severe weather threats will include large hail, damaging wind, and possible tornadoes.

Overnight, state responders assisted with multiple high-water rescues in Central and Southeast Texas. Additionally, state transpor-

tation and law enforcement personnel have assisted with road closures and sandbagging efforts. Impacted school districts are reporting altered schedules due to weather impacts.

The Texas State Emergency Operations Center continues to operate at Level II (Escalated Response), with 24-hour emergency management council operations, in order to support requests for state assistance from local officials in areas impacted by storms and flooding.

Texans are urged to monitor local forecasts, make an emergency plan, and follow instructions of emergency response officials. Never drive or walk through flooded roads, and do not drive around barricaded roadways. Remember: Turn Around, Don't Drown.

Governor Abbott continues to take action to provide all available resources to help support local communities from the impacts of severe weather, including:

- Ready state emergency response resources ahead of wildfire and severe weather threats last week
- Issuing a disaster declaration yesterday for counties affected by recent storms and deploying additional state emergency response resources in anticipation of severe weather and flooding this week
- Increasing the readiness level of the State Emergency Operations Center to help support requests for state assistance from local officials

Governor Greg Abbott today expanded the state's disaster declaration to include 59 counties in at-risk areas for severe weather and flooding, with the updated disaster declaration covering 88 counties in total. Additional counties may be added as conditions warrant.

"As flooding conditions and severe weather continue in multiple regions across Texas, I expanded the disaster declaration to add 59 counties to ensure Texans and their communities receive the assistance and support they need to stay safe," said Governor Abbott. "For Texans in at-risk areas, it is important to remain weather-aware, follow the guidance of state and local officials, and avoid traveling in dangerous flood conditions. The State of Texas continues working with emergency management and local officials to deploy any additional resources needed to provide ongoing support and protect our fellow Texans."

The counties added to the disaster declaration include: Anderson, Angelina, Austin, Bandera, Bastrop, Bell, Bexar, Blanco, Bosque, Brazos, Burleson, Burnet, Caldwell, Cherokee, Colorado, Comal, Coryell, DeWitt, Falls, Fayette, Gillespie, Gonzales, Gregg, Guadalupe, Hamilton, Hardin, Hays, Henderson, Houston, Jasper, Jefferson, Johnson, Karnes, Kendall, Kerr, Kimble, Lampasas, Lavaca, Lee, Llano, Mason, Medina, Milam, Nacogdoches, Newton, Orange, Panola, Robertson, Rusk, Sabine, San Augustine, Shelby, Smith, Travis, Van Zandt, Waller, Washington, Williamson, and Wilson counties.

HOUSTON STILL NO. 1 CITY FOR TRADE IN U.S.; 70K JOBS ADDED IN PAST YEAR

Houston's job growth is slowing down compared to two years ago.

That's according to the Greater Houston Partnership. Every year the GHP looks into Houston's global economy, offering insight into the region's major trading partners and trends affecting the area's international trade.

Senior VP of Research Patrick Jankowski joined Houston Matters on Friday and said that the city is still doing well, despite the slowdown. The city added around 70,000 jobs in the last 12 months, he said.

"That's lower than what we did last year," Jankowski said. "Last year we had 102,000. We are slowing but we are still growing."

The rates are closer to pre-pandemic years, he added.

"What we're doing is returning to normal after all these years and months, we are back to normal."

In the Houston area, about \$175 billion in trade happens, which makes it the number one city in the U.S. for shipping and trading. Jankowski said for Houstonians, this means jobs.

"If we did not export as much as we had, we would not have as robust an economy and we would not have as many jobs in the region," he said.

Houston's biggest trade partners are China and Mexico, Jankowski said.

"They actually flip flop every now and then, one year it's Mexico, the next year it's China and then it goes back and forth," he said. "But the top five are: China, Mexico, the Netherlands, South Korea and Brazil."

Among the top 20 are Colombia, Chile, Thailand, and Germany.

Some of the major exports from Houston include crude and refined products, steel, industrial equipment, electrical equipment, plastics and chemicals.

"And we still export agricultural products," he said. "Agricultural products aren't necessarily growing around here, but I was surprised to see that if you look at what goes out by containers, among the top 10 exports are ... cotton."

While trade is part of it, there's also direct foreign investment. In 2023, 52 countries overseas announced that companies headquartered in other countries would have operations in Houston, whether through a warehouse, office, research and development or service center.

"Last year we saw an awful lot of companies that would be in alternative energy," he said. "I also saw a number of life sciences companies. ... They're coming to Houston because of the engineering talent, and they're coming to Houston be-

cause we already have a very large life science and healthcare sector here."

Houston also has about 1.7 million foreign-born citizens, about 1 in 4 Houstonians. That number surprised him, Jankowski said.

"As an economy of roughly \$600 billion, foreign-born workers, their output, their contribution to the GDP is about \$200 billion; that's huge," Jankowski said. "The other thing is when you look at some of the countries that we trade with, we actually trade more with Vietnam than we do with Saudi Arabia, and we actually trade more with Ecuador than we do with Australia and that was a surprise to me."

One of Houston's greatest strengths is the port and the companies based in the area. But the area's weakness is infrastructure.

"It's great to see what the ports are doing, what the airports have done, but we still need to do some investment in our roads and our freeways," he said. "You can get it to the port, but you've got to get it from the port onto a flatbed of some sort, and haul it out or bring it in."



ing, Verlander has thrown at least 95 pitches in each of his past three starts -- and against the Yankees, velocity on all four of his pitches was up from his yearly average.

“[I felt] pretty good physically ... everything has been feeling pretty good,” Verlander said. “I would like to have a tick or two more velo on my fastball, which is something I’ve been expecting because I wasn’t able to long toss really at all. And that’s something that can get me going a little bit.”

But where the physical feel remained, Verlander admitted that a loosened grip on his mechanics contributed to a lack of success against a Yankees lineup that might know him better than any other in the Majors.

Deception takes many forms, but one sign that you’re not fooling anyone is low swing-and-miss totals. According to Statcast, Verlander only induced six whiffs against the Yankees (three each on curveballs and sliders), and both the amount of horizontal and vertical movement on each of his pitches was down. When the walk totals outnumber the strikeout numbers -- three free passes against two punchouts on Tuesday -- it’s not hard to believe there’s room for improvement.

The precision and accuracy struggles plagued Verlander early. He walked Aaron Judge on five pitches in the first frame, yanking sliders and fastballs off the outside corner to put two runners on ahead of Alex Verdugo. Then against the left-handed-hitting outfielder, he spent the majority of the at-bat peppering the outside corner, before attempting to pressure Verdugo with an up-and-in fastball on the seventh pitch; however, Verlander missed his spot and Verdugo deposited a low-and-inside 95 mph four-seamer into the right-field bleachers. A microcosm of Verlander’s evening.

“Tried to go up-and-in, threw

it down-and-in -- threw it right where he likes it,” Verlander said. “That’s really the pitch that’s probably going to nag me most tonight. But obviously, that wasn’t the ball-game.”

For Verlander, who has made 513 career regular-season starts, tonight was just another alert that adjustments have to be made. From his point of view, it’s by no means cause for alarm -- just another opportunity to return to the drawing board and come back stronger. Something he’s done time and time again in his 19-

year career.

“If anything, I figured out that I need to be better, so I’m gonna go,” Verlander said. “Starting tomorrow, I have a lot of work to do. Been here, countless times in my career. One of the things about being a veteran is knowing yourself and knowing when you’re right. You don’t just throw away games like this and say, ‘OK, I’ll be better next time.’

“There’s a reason. And you’ve got to start turning over stones and find that reason.”

There’s been somewhat of an air of invincibility around Justin Verlander when he steps onto the mound against the Yankees while wearing an Astros uniform.

Entering Tuesday night at Yankee Stadium, the likely future Hall of Famer had only lost two games to New York in the regular season, with Houston holding a 6-3 record in those starts. And that’s without even mentioning his masterful postseason duels he’s had against the Bronx Bombers, like Games 2 and 6 of the 2017 American League Championship Series, or his herculean six-inning effort in Game 1 of the 2022 ALCS.

Even with the 41-year-old making just his fourth start since recovering from right shoulder inflammation, the Astros feel the utmost confidence with Verlander on the mound.

What followed was a continuation of Houston’s early-season doldrums, as it suffered a lopsided 10-3 defeat to the Yankees, dropping to 12-23. A quiet offensive night -- highlighted by Kyle Tucker’s first-inning solo homer -- was magnified by a particularly tough outing for Verlander. He allowed seven earned runs (the most he’s given up to New York as an Astro) on eight hits, surrendering three home runs.

Before the loss, Espada mentioned that he’s been encouraged by how Verlander has shouldered the load since returning from injury, noting his ability to pitch late into games without a visible decrease in stuff. Including Tuesday’s out-

H-TOWN BLUE: THE COLOR THAT DEFINES HOUSTON'S SPIRIT

The light blue color, known as Columbia Blue, has a rich history in Houston that extends beyond its association with the Houston Oilers. This color has been a significant part of Houston's identity for over a century, symbolizing the city's heritage and its foundational industries. The city's flag, adopted in 1915, prominently features light blue, representing the city's heritage and its foundational industries, such as the locomotive and the plow, which are depicted in the city seal. This early adoption of light blue in the city's flag underscores its historical and cultural importance, predating the establishment of the Houston Oilers in 1960.

The Houston Oilers, estab-

lished in 1960, adopted Columbia Blue as their primary color, a decision influenced by the team's owner, Bud Adams, who had a personal affinity for the color due to his connections with the University of Kansas. This choice not only set the Oilers apart in the American Football League but also began a tradition of light blue in Houston sports.

Following the relocation of the Oilers to Tennessee in 1996, the legacy of Columbia Blue continued in Houston through the Texans, the city's current NFL team. The Texans have incorporated a similar shade, known as H-Town Blue, into their uniforms and branding. Despite the Tennessee Titans holding the intellectual property rights to the Oilers' trademarks, the Texans' move to honor the city's sports history and

reinforce the color's significance as a symbol of Houston's identity demonstrates the enduring connection to the color.

The University of Houston has also played a pivotal role in maintaining the color's relevance in the city. Despite facing legal challenges from the NFL, which issued a cease-and-desist letter over the use of a similar shade of blue in their uniforms, the university stood firm. They informed the league of their intention to continue using the color, highlighting the city's historical ties to it and challenging the notion that the NFL could monopolize a color deeply embedded in Houston's culture. This defiance underscores the broader community's attachment to the color and its significance beyond

the realm of professional sports.

The color's cultural impact is evident in other aspects of Houston's life, such as the Houston Police Department's historical use of light blue for their squad cars. This further cements the color's place in the city's cultural landscape, beyond its sports teams.

In essence, H-Town Blue, as it is now known, transcends its origins with the Houston Oilers to embody Houston's history, pride, and community spirit. It represents a unifying symbol for the city, reflecting its past achievements and aspirations for the future. So, no Titans fans Houston is not stealing your "colors", it's a part of our city's history.




