## SEPTEMBER MARKS 22ND CONSECUTIVE MONTH OF UPSTREAM OIL AND GAS JOB GROWTH: 47% OF JOBS RECOVERED

Texas oil and natural gas companies added 1,100 upstream jobs\* in September, marking the 22nd consecutive month of job growth, according to data from the Texas Workforce Commission (TWC). Texas has recovered 47% of jobs lost between the high point in employment in December 2014 and the low point in September 2016. 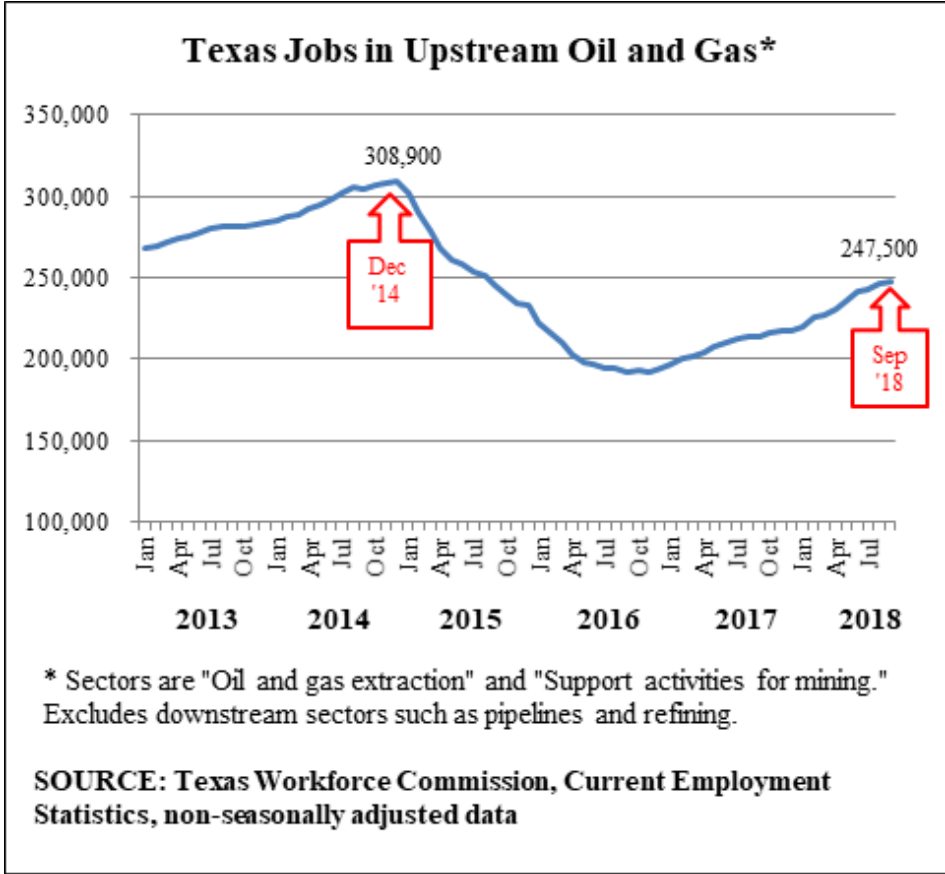

## GOVERNOR ABBOTT REQUESTS PRESIDENTIAL DISASTER DECLARATION IN RESPONSE TO SEVERE WEATHER AND FLOODING

Governor Greg Abbott today sent a letter to President Donald Trump requesting a Presidential Disaster Declaration for Texas counties heavily impacted by recent severe weather and flooding that caused widespread damage across the state. Additional Texas counties may be added to the declaration as local, state, and federal agencies continue to assess damages.

“The magnitude of recent severe weather and flooding has taken a serious toll on Texans across the state,” said Governor Abbott. “With such widespread flooding and devastation, additional resources are needed to help Texans recover. This request will help provide assistance and emergency services for Texans impacted by this disaster, and I thank the President for his continued support.”

Governor Abbott has included the following counties in his request for a Presidential Disaster Declaration, which, if granted, would allow those affected to apply for Individual Assistance (IA), Other Needs Assistance (ONA), Crisis Counseling, Disaster Unemployment Assistance, Disaster Legal Assistance, and Disaster Case Management: Burnet, Ellis, Haskell, Liberty, Llano, Sutton, Tarrant and Travis counties.

Public Assistance Categories A through G including Direct Federal Assistance have been requested for Baylor, Brown, Burnet, Callahan, Coleman, Fannin, Gillespie, Haskell, Hill, Hopkins, Houston, Jones, Kerr, Kimble, Knox, Leon, Llano, Madison,

Mason, Nolan, San Patricio, San Saba, Sutton, Throckmorton and Travis counties.

In addition to the Presidential Disaster Declaration request, Governor Greg Abbott today also expanded his State Disaster Declaration to cover a total of 111 Texas counties. Governor Abbott has authorized the use of all available resources of state government and of political subdivisions to aid in the response efforts.

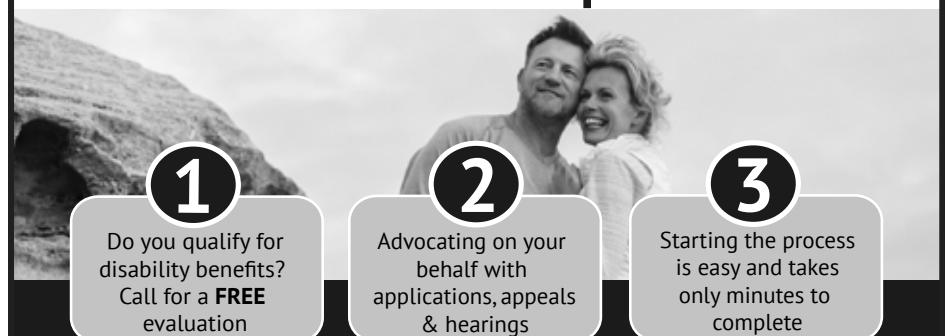

## HOUSTON MUNICIPAL COURTS ANNOUNCES FALL AMNESTY PROGRAM

For the next 3 weeks, the City of Houston Municipal Courts Department (MCD) will discount certain delinquent cases to help individuals save money when they resolve those cases.

“Many of our citizens are still putting the pieces back together from Harvey, and we understand that sometimes many are not able to meet all their obligations,” stated Judge J. Elaine Marshall, Director and Presiding Judge of the Municipal Courts Department. “We are hoping this final Amnesty of the year will give everyone the opportunity to clear up old business, reduce the stress that delinquent cases cause, to start the new year off fresh,” said Judge Marshall.

The Amnesty Program will begin Friday, October 26, 2018 at 8:00 a.m. and ends Saturday, November 17, 2018 at 11:59 p.m. Any defendant who voluntarily appears at any Municipal Court location during the amnesty period will be permitted to resolve all of their eligible delinquent cases, including Failure to Appear (FTA) cases, and will not be subject to arrest. Cases eligible for amnesty include cases that were delinquent prior to September 1, 2018. Only the defendant named in the citation or their attorney can participate in the Amnesty Program. Bonding companies, friends, relatives, and spouses cannot make the amnesty request on behalf of someone else.

The Amnesty Program does not apply to a defendant that is in custody, previously adjudicated cases, parking citations, administrative violations, bond forfeitures, or civil cases. Individuals may call the Houston Helpline by dialing 3-1-1 or 713-837-0311 for questions about whether their specific case(s) is amnesty eligible. Defendants may take advantage of the Amnesty Program by phone, US Mail or in person at any Municipal Court location. ### 2018 Amnesty Program FAQ's

#### Why are you doing this?

To resolve cases for which all other means of resolution have been unsuccessful and to assist the citizens of Houston with any lingering outstanding Municipal Court issues.

#### When does Amnesty begin?

The Amnesty Program begins Friday, October 26 and ends at Saturday, November 17, 2018 at 11:59pm.

#### What kinds of cases are eligible for Amnesty rates?

Most delinquent traffic and non-traffic citations that were delinquent on or before September 1, 2018 will be eligible for Amnesty discounts. Parking citations and Administrative violations are not eligible for Amnesty. Citizens may call 3-1-1 to find out if they have eligible Amnesty cases.

#### What do I do if I have a delinquent parking citation?

Parking citations are not eligible for Amnesty. For additional information or assistance regarding paying your parking citation, please call 311 or 713.837.0311.

#### How can I find out if I have warrants?

Dial Houston's Helpline at 3-1-1, visit the website at [www.houstontx.gov/courts](http://www.houstontx.gov/courts) or come in person at any City of Houston Municipal Court location.

#### What are my options if I find out that I have warrants?

You may pay the fines at the applicable Amnesty rates if your cases qualify. You may also be able to post a bond and have your case(s) reset for a new court date. You always have the option to seek legal advice from an attorney or come to any City of Houston Municipal Court location to speak with a judge.

#### If I come to court to pay, will I

be arrested?

No. The City Houston Municipal Courts will not arrest individuals who visit our courthouse to inquire about their delinquent cases. We encourage everyone to come in voluntarily to resolve their cases.

#### If I want to pay for my delinquent cases/warrants, what are my payment options?

Payment options are as follows: Phone (3-1-1, 713-837-0311), U.S. Mail, or In-Person at any City of Houston Municipal Court loca-

tion.

#### What forms of payment do you accept?

We accept cash, checks, money orders, and American Express, Discover, MasterCard and Visa.

#### After I pay, how long will it take to clear my driving record through DPS?

The City of Houston Municipal Courts Department will forward the information to DPS upon payment of your case(s). Please allow 5 to 7 business days for your driving record to clear through DPS.

Hasta la fecha, la organización ha comprometido más de 140 millones de dólares de becas para los DREAMers.

La nueva ronda de becas viene después de la reciente publicación de un reporte de TheDream.US que resume las respuestas y las implicaciones de una encuesta nacional de 1,400 becarios de TheDream.US. Los resultados de la encuesta subrayan lo importante que son los logros educativos para los sueños y futuros de los becarios, mientras que muestran un retrato de la incertidumbre y la ansiedad que enfrentan los becarios en un difícil clima de inmigración, en particular con el anticipado fin de DACA y TPS.

Según Donald E. Graham, el exeditor del Washington Post y cofundador de TheDream.US, "Seguimos totalmente comprometidos a ayudar a los DREAMers a acceder a una educación universitaria. Pero, seamos claros, el compromiso más poderoso sigue siendo de los propios DREAMers. Como se describe en 'En

sus propias palabras' y como lo demuestra el número récord de aplicaciones de becas que TheDream.US recibió el año pasado, los DREAMers se mantienen firmes ante la creencia de que nadie puede quitarles la educación universitaria".

TheDream.US anunció la expansión de la disponibilidad de ayuda estatal para los DREAMers de New Jersey. En un contraste desafortunado, la Corte Suprema de Arizona hizo más difícil que los DREAMers de Arizona accedieran a la educación universitaria en un fallo que negaba a estos estudiantes la matrícula estatal.

Reconociendo el impacto devastador que esto podría tener en los DREAMers de Arizona, Benedictine University Mesa y Grand Canyon University se unieron a Arizona State University para servir a TheDream.US becarios que quedaron en el limbo. Las tres universidades han acordado cerrar la brecha entre los costos de matrícula y las cuotas y la beca.

TheDream.US ofrece dos becas. La beca Nacional de hasta 33,000 dólares para una licenciatura es para graduados de la escuela secundaria o del colegio comunitario. La Beca de Oportunidad de hasta 80,000 dólares es para estudiantes que viven en estados específicos y cerrados donde no pueden obtener la matrícula dentro del estado y les brinda la oportunidad de asistir a una universidad asociada fuera de su estado natal

## KAREEM JACKSON "KILLING IT" AT SAFETY, CORNERBACK IN 2018

**K**areem Jackson has made his mark, repeatedly, this season in the Texans' defensive backfield.

The nine-year veteran switched positions to safety over the offseason, flourished there throughout the early going, and segued successfully back to cornerback over the last month. On Sunday in Denver, he was a physical presence for the Texans defense, coming up with four tackles and a pair of pass breakups in the 19-16 victory over the Broncos. He was so impactful, he passed the eye test for head coach Bill O'Brien in the postgame press conference.

"It was noticeable on the sideline," O'Brien said. "A lot of time I have to tell you, 'I have to watch the film,' but it was noticeable how well he played tonight."

"He is killing it," defensive end J.J. Watt said after the win in Denver. "That hit today was one of the hardest hits I have seen on a football field. It was clean. It was a great hit. He has been doing that all year. He has been getting interceptions, making big hits, and making tackles."

For Jackson, who's fourth on the Texans with 51 tackles, the recognition has been nice.

"It's just all about being consistent and being a piece of the puzzle here," Jackson said Monday. "I just want to come in,

whether I'm playing corner or safety or in the slot, whatever I have to do to be a guy that can contribute and to be consistent in what I do on a weekly basis."

The Texans' career leader in interceptions with 16, he has a pair this year. Jackson's also forced two fumbles, recovered another, and tallied four tackles for loss. Doing it all while shuffling positions isn't easy, according to safety Tyrann Mathieu.

"I don't think many people realize how hard that is, how much studying, how much responsibility that is on a player," Mathieu said. "He's been holding it well, obviously, playing well, setting the fire, setting the tempo for us on defense."

Jackson and the Texans are off this week with a bye, and will return to action a week from Sunday at Washington.

## INGREDIENTS:

- 1 package Gluten Free Pie Crust Mix as prepared, see notes
- 4 pounds Granny Smith Apples peeled and cored, about 8 apples
- 1/2 cup Sugar plus 1 Tablespoon for topping
- 1 Tbsp Fresh Lemon Juice
- Lemon Zest from one lemon
- 1/4 tsp Salt
- 1/4 tsp Nutmeg
- 1/4 tsp Cinnamon
- 1 Egg White or 1/8 cup of milk for topping

# AMAZING APPLE PIE

## INSTRUCTIONS

1. Prepare pie crusts according to basic instructions. Keep dough for top crust refrigerated. Roll out bottom crust and place in a 9- inch pie pan. Place pan in refrigerator.
2. Preheat oven to 425°F.
3. Cut apples into 1/4- inch slices and place in a large bowl. Add 1/2 cup sugar, lemon juice, lemon zest, salt, and spices. Stir to coat.
4. Remove pie pan from refrigerator. Pour apple mixture into pie shell. Remove dough for top crust from refrigerator. Roll out top crust and place over filling.
5. Trim dough edges, leaving 1/2- inch overhang. Tuck overhanging dough beneath itself and flute edges.
6. Cut three slits in top crust for steam to escape as the filling bakes. Place pie in freezer for 10 minutes.
7. Remove from freezer and and

brush lightly with egg white or milk and sprinkle with 1 Tablespoon of sugar. Bake on center rack for 25 minutes at 425°F. Reduce temperature to 375°F and place a foil lined baking sheet on the lower rack to catch juice if it bubbles over.

8. Continue baking for 30-35 minutes more, until crust is golden brown and juices bubble. Remove from oven and cool on a wire rack for 1 hour before serving.
